Title I is a federally funded program designed to improve educational opportunities by providing aid to elementary and secondary education. The intent, of Title I, is to expand learning opportunities while supplementing basic skills instruction in reading. This program serves students who need to improve their reading skills. The goals of the Title I program are to:

- Develop positive attitudes towards reading/language arts
- Individualize reading/language arts instruction according to student needs
- Increase reading/language arts achievement
- Increase student self-esteem
- Involve children with parent(s) in reading/language arts activities at school and at home

#### TITLE I PROGRAM AT MILLCREEK-WEST UNITY LOCAL SCHOOL

The Title I program at Millcreek-West Unity Local School has been designed to improve the educational success for all students enrolled with the program. Based on the assumption all children are capable of learning and student achievement is in direct correlation to expectations set, the following goal has been set: to emphasize improved reading and language arts outcomes by providing support to students in these areas as higher standards of learning are implemented. The Title I program is designed to reach as many students as possible providing them with the opportunities and support needed to achieve higher standards of performance within the classroom. Individual or small group help is provided to students who are "struggling" with a given concept – determined by the classroom teacher through the use of pre/post testing, daily work, and informal observations.

# **HIGHLY QUALIFIED STAFF**

The Title I staff has met and/or exceeded the criteria set by the State of Ohio for highly qualified teachers. All paraprofessionals within the school have met the requirements for being highly qualified through passing the State Paraprofessional test or having the needed college credits.

#### PARENT'S RIGHT TO KNOW

What do I know about my child's teacher? The federal education law called "Every Student Succeeds Act" requires all parents be notified and given the opportunity to request information about the professional qualifications of classroom teachers instructing their child and paraprofessionals working with their child. # **Philosophy of Parent Participation**

- 2. Parents' suggestions in planning, developing, and implementing the Title program.
- 3. Parents will be encouraged to assist in the Title projects such as planning and implementing them.
- 4. Timely information, materials, and suggestions will be provided to help parents promote the education of their child at home.
- 5. Copies of this policy will be available at the annual parent/ teacher conferences.

#### Millcreek-West Unity School District Parent Involvement Policy

#### Millcreek-West Unity School District will do the following:
